- 4 Fridays she gets out at three --
- 5 CHAIRMAN QUILES: Is that state mandated?
- 6 MS. DAY: That's the new minimum amount you
- 7 have to work to get into the pension. And, otherwise,
- 8 we can change the hours and make everybody, and then
- 9 it's going to cause -- so this worked out much better
- 10 this way.
- 11 MR. GEISLER: Who wants to -- can I have
- 12 somebody sponsor this one?
- 13 CHAIRMAN QUILES: I'll sign it.
- 14 MR. GEISLER: Second?

- 13 you look, a lot of times you have raised sidewalks. We
- 14 had a guy come in, and rather than put concrete, we had
- 15 them shaved so there's no lips. So it's a pretty neat
- 16 thing. If you look around, we don't have any --
- 17 hopefully we don't have any tripping hazards, and
- 18 that's a good thing.
- 19 CHAIRMAN QUILES: I would like to say
- 20 something, if I may. I want to thank our
- 21 commissioners, Ms. Ribaudo and Mr. Dabal and
- 22 Mr. Giacomarro, even though you weren't able to make
- 23 it --
- MR. GIACOMARRO: Sorry.
- 25 CHAIRMAN QUILES: -- for taking the time to

- 1 diligently do this for our work force. I think the
- 2 people that we have here at the Garfield Housing
- 3 Authority do a great job. And I also know that we live
- 4 in a very expensive area and I know the cost of living
- 5 here is very high. I think what we're doing right now
- 6 is the right thing to do. So, again, thank you for
- 7 doing what you're doing for our employees.
