- 2 meeting has been provided at least 48 hours in advance
- 3 by publication in The Record and by posting a notice of
- 4 this meeting on the community bulletin board at the
- 5 Garfield Housing Authority and Garfield City Hall.
- 6 (All rise for the recitation of the Pledge of
- 7 Allegiance.)
- MS. FIORE: And we can just have a moment of
- 9 silence for Tony DeMarco.
- 10 (Moment of Silence.)
- MS. FIORE: Okay. Roll call for the regular
- 12 meeting held on February 25, 2019.
- MR. DABAL: Here.
- MS. RIBAUDO: Here.
- MS. SUSINO: Absent.
- MR. GIACOMARRO: Absent.
- MS. BARCKETT: Here.
- MR. PUZIO: Here.
- 19 CHAIRMAN OUILES: Here.
- MS. FIORE: Approval of the minutes from
- 21 transcript of the caucus and regular meeting held on
- January 28, 2019. Somebody make a motion?
- MR. DABAL: Motion.
- MR. PUZIO: I'll second it.
- MR. DABAL: Yes.

MR. PUZIO: I got a comment to make. On the

- 2 minutes, I think I found an error on page five. I
- 3 might be wrong.
- 4 MS. FIORE: The caucus one or --
- MR. PUZIO: Oh, no, on the regular minutes.
- 6 I wanted to bring it up in caucus. I was distracted.
- 7 MR. DE MARCO: You said page five, Mr. Puzio?
- MR. PUZIO: On the regular minutes I spotted
- 9 that you voted for and it was Eddie who voted. Let me
- 10 see if I can find it.
- MS. FIORE: Where it says "abstain"?
- MR. PUZIO: This is on the minutes, not on
- 13 the caucus.
- MS. FIORE: No, this is the regular.
- MR. PUZIO: Let me put my glasses on.
- MS. FIORE: I think we were discussing it.
- 17 So I would say, "Are you abstaining?" Like asking a
- 18 question; "Are you abstaining?"
- MR. PUZIO: I corrected it. I put Eddie
- 20 Dabal's name there, but I don't know the legal opinion
- 21 on that.
- MR. DE MARCO: No, no. That was Margaret
- 23 inquiring as to Chairman Quiles as to whether he was
- 24 abstaining on that particular vote. So the transcript
- 25 is correct.

- MR. PUZIO: But it doesn't have anything in
- 2 there that Eddie voted.
- MS. RIBAUDO: It was him who abstained.
- 4 MS. FIORE: Oh, but it didn't --
- 5 MR. DABAL: But I voted yes. He's saying it
- 6 doesn't say that.
- 7 MR. DE MARCO: It doesn't reflect your vote.
- MR. PUZIO: It's not there, because that's on
- 9 the resolution.
- MR. DE MARCO: Right. So the question mark
- 11 would be "Abstain?" should remain, because that was
- 12 discussed. And the record should reflect and the
- 13 transcript should reflect that Mr. Dabal voted in the
- 14 affirmative.
- So with that correction, does -- Mr. Dabal,
- 16 you made a motion to approve the transcripts. Do you
- amend your motion to reflect that correction?
- MR. DABAL: Do I amend my motion?
- MR. DE MARCO: Yes.
- MR. DABAL: Okay.
- MR. DE MARCO: And, Mr. Puzio, you second the
- 22 motion as amended, correct?
- MR. PUZIO: Yes.
- MR. DE MARCO: Now we can make a roll call.
- MR. DABAL: Yes. Here.

- 1 MS. RIBAUDO: Here. Yes.
- MS. BARCKETT: I don't think I can vote. I
- 3 wasn't here last month.
- 4 MR. DE MARCO: Right. You have to abstain.
- 5 MS. BARCKETT: I abstain.
- 6 MR. PUZIO: Yes.
- 7 CHAIRMAN QUILES: Yes.
- 8 MS. FIORE: Bills presented for payment
- 9 February 25, 2019. Operating account expense in the
- 10 amount of \$107,833.01. Capital fund 501-17 in the
- amount of \$18,657.43. Capital fund 201-18 expenses in
- 12 the amount of \$32,337.35. And Ross Grant 17 expenses
- in the amount of \$5,383.15. For the total amount of
- 14 \$164,210.94.
- 15 Is there a motion?
- MR. DABAL: I'll make it.
- 17 MR. PUZIO: I second it.
- 18 MR. DABAL: I abstain on check number 1004.
- 19 Yes on the rest.
- MS. RIBAUDO: Yes.
- MS. SUSINO: Absent.
- MS. FIORE: I know. I can't. I think you're
- 23 making me -- you're right. All night. Susino absent.
- MR. DE MARCO: At least you're consistent.
- MR. GIACOMARRO: Absent.

- 1 MS. BARCKETT: Yes.
- MR. PUZIO: I abstain on check number 19484
- 3 and 19485. Aye on the rest.
- 4 CHAIRMAN QUILES: Yes.
- 5 MS. FIORE: Any public comment?
- 6 MR. A.J. MONTONE: On that?
- 7 MS. FIORE: In general.
- MR. A.J. MONTONE: Yes, yes. My name is A.J.
- 9 Montone. My girlfriend and my three daughters live
- 10 over by -- on 229 Midland Ave. On December 30th, we
- 11 had an argument at 10:30 in the morning. Okay. The
- 12 police officer that lives on the third floor came
- downstairs. Nothing physical happened. There was no
- 14 issue. I ended up leaving. That was the end of it.
- A week later my girlfriend gets a knock at
- 16 the door apparently from someone coming from Marty
- 17 saying that -- with the piece of paper -- I have a
- 18 history with Marty, but that's besides the point. With
- 19 a piece of paper saying, basically, if I'm on the
- 20 property again, my girlfriend and my three daughters
- 21 will be kicked out and evicted from the Housing.
- Okay. I called Margaret here to try to ask,
- 23 well, I don't understand why, you know, this would spur
- 24 that with no arrest. I mean, nothing happened. There
- 25 was no restraining order. There was no issue. And she

- 1 basically just said, have your lawyers contact my
- 2 lawyer or our lawyers and --
- 3 MS. GAIL MONTONE: She hung up on him.
- 4 MR. A.J. MONTONE: And hung up me. So, I
- 5 mean, I don't feel I need to go get a lawyer really for
- 6 something like this. I don't understand why I would be
- 7 barred from the Garfield Housing and be arrested if I
- 8 step foot on the property. I don't understand.
- is causing me not to see my children, my girlfriend. 9
- 10 MS. GAIL MONTONE: He can't pick them up.
- 11 MR. DE MARCO: Ma'am, you can't speak until
- 12 it's your turn.
- 13 MS. GAIL MONTONE: Okav.
- 14 MR. DE MARCO: You stand up and you identify
- 15 yourself for the record.
- 16 Yeah, this is affecting me MR. A.J. MONTONE:
- 17 picking my kids up, helping my girlfriend bring
- 18 groceries in the house even. Help with the laundry.
- 19 Anything. I can't even go on the property.
- scared to death that she's going to get evicted and not 20
- 21 have a place to live. She needs help. She has a
- 22 full-time job. We have three kids.
- 23 I'm going to school right now. I'm going to
- trade school right now, so I'm not really bringing in 24
- 25 much money. She needs my help. I don't live there. I

- 1 have another address. I understand I'm not on the
- 2 lease. I'm not there that much. But like for
- 3 something so small to blow it up into something this
- 4 big is ridiculous. And I don't feel it's fair that I
- 5 shouldn't be allowed on the property at all to pick my
- 6 kids up, to drop them off or to help my girlfriend do
- 7 anything at all.
- 8 She's lived there her entire life. I've been
- 9 going there since -- we've been dating since 2006. I
- 10 have been going there since 2006. She's lived there in
- 11 that building. Okay.
- MS. BARCKETT: Can I ask you a question?
- MR. A.J. MONTONE: Yes. Absolutely.
- MS. BARCKETT: Has this happened before? An
- 15 argument? Has it happened before?
- MR. A.J. MONTONE: An argument between us,
- 17 no.
- MS. BARCKETT: One argument they're going to
- 19 tell you you can't come over here?
- MR. A.J. MONTONE: No. An argument never
- 21 happened. Back in 2007, 2007, mind you, I had just
- 22 gotten out of prison. I haven't been in trouble since.
- 23 I had just gotten out of prison. I had a distribution
- 24 charge in 2003. I was in court. You know, went to
- 25 prison, did my time, maxed out, came home.

- 1 A month later, October 30th, I remember the
- 2 exact date, I was standing out front having a
- cigarette. Officer Heath Hicks, who used to be the 3
- 4 DARE officer over there, who I grew up with -- because
- 5 I grew up in Garfield. I grew up in this town.
- 6 and raised. Went to all schools here, high school,
- 7 everything. Came over and said, hey, how you doing?
- 8 We know you just got out of prison and everything.
- 9 Well, because you have a distribution, I'm sure you
- 10 guys know, you're not allowed to get housing. Like I'm
- 11 not allowed to be on the lease. I'm not allowed to
- 12 live there.
- 13 Well, at the time, they were under the
- 14 impression --
- 15 MS. GAIL MONTONE: No. You can rape
- 16 somebody --
- 17 MR. DE MARCO: Ma'am, ma'am.
- 18 MR. A.J. MONTONE: At the time they were
- 19 under the impression that I'm not even allowed to be on
- 20 the property. So I was arrested. We went to Garfield
- 21 Municipal Court. The charges were dropped. Okay.
- 22 Her mother, Linda, who also lives in the
- 23 building, I would say the last time was 2009, she
- 24 called the police on me and her daughter, Lauren, at
- 25 the time. We were just in her bedroom. And she wanted

- 1 both of us out of the house. She didn't tell us. We
- 2 were just in Lauren's room and she called the police.
- 3 And they came and brought me out and said, hey, you're
- 4 not allowed to be here. Arrested me for being on the
- 5 property. Nothing else. Went to court again. Charges
- 6 were dropped, because that wasn't the case. I'm just
- 7 not allowed to live there. I'm allowed to visit
- 8 whoever I want. And that was it. That is the extent
- 9 of everything that's happened with the police in my
- 10 entire life there.
- Now, Marty's aware of all this. Curt Geisler
- 12 was my public defender in Garfield, actually, for
- 13 these. So they know about the previous two that were
- 14 dropped in court. But still, I mean, you know, I feel
- 15 they kind of hold a personal grudge against me. They
- 16 don't really like me. I mean, at the time, I wasn't
- 17 really too happy with his legal counsel, you know, but
- 18 whatever. That's beside the point. It's irrelevant at
- 19 this point.
- I just don't feel it's fair. I don't want to
- 21 have to go through a lawyer or anything like that. I'm
- 22 not asking for anything crazy. Nothing like this will
- 23 ever happen again. We were arguing verbally, it was
- 24 just a verbal argument, over disciplining our three
- 25 children. Our oldest, our seven-year-old. We have a

- 1 seven-year-old, a three-year-old and 18-month-old.
- 2 That's what me and my girlfriend were arguing over at
- 3 the time. So --
- 4 CHAIRMAN QUILES: You said you called here
- 5 and somebody hung up?
- 6 MR. A.J. MONTONE: Margaret. I called to try
- 7 to work this out, you know, without having to come
- 8 here. And she basically said, I don't want to hear it.
- 9 Straight out, I don't want to hear it. Have your
- 10 lawyers call our lawyer. And hung the phone up on me.
- 11 So, I mean, I don't feel -- if I have to, I
- 12 will. I mean, I will do anything. My kids are my
- 13 world. That's why I'm going to school, trade school
- 14 now, so I can get a great job and take care of them.
- 15 Get them out of the Housing, hopefully. But, for the
- 16 meantime, I have to be able to see my kids. This is
- 17 barring me from seeing my children.
- MR. PUZIO: Do you have a restraining order
- 19 against you?
- MR. A.J. MONTONE: No. I have no
- 21 restraining -- Lauren and I have never had a
- 22 restraining -- we've been together 13 years. We've
- 23 never had a restraining order against one another. We
- 24 never had a charge pressed against one another.
- MR. PUZIO: Will she open the door for you

- 1 when you come there?
- 2 MR. A.J. MONTONE: I haven't been there since
- 3 December 30th. Because I won't put her in a position
- 4 where if I step on that property she'll get in trouble
- 5 and not have a place for my kids to say.
- 6 MS. GAIL MONTONE: But they were over this
- 7 weekend.
- MR. A.J. MONTONE: My kids, she brings them
- 9 over to the house. We live in Kearny. My kids were
- 10 over over the weekend. Like, you know, she's five
- 11 three, you know, 105 pounds. Carrying groceries in by
- 12 herself.
- MR. PUZIO: We got a problem. There's two
- 14 sides to a story.
- MR. A.J. MONTONE: There is two sides to a
- 16 story.
- MR. PUZIO: We're only hearing one side.
- MR. A.J. MONTONE: You are hearing one side.
- MR. PUZIO: Well, we don't know maybe she
- 20 don't want you there anymore.
- MR. A.J. MONTONE: Well, in that case --
- MR. PUZIO: Apparently that's what's been
- 23 happening.
- MR. A.J. MONTONE: No, that's not what's been
- 25 happening. I haven't been there.

- 1 MS. GAIL MONTONE: Call her.
- MR. A.J. MONTONE: No. I haven't been there
- 3 since the 30th, because I don't want her to get in any
- 4 trouble. Because she -- like I said, a week or two
- 5 later, someone came and made her sign something saying
- 6 that if she allows me on the property or I'm there for
- 7 her, even step foot on the property, that she and my
- 8 children will be evicted and thrown out. So I haven't
- 9 went there. Out of my own -- my own, just by myself, I
- 10 haven't went there, because I wanted to do it the right
- 11 way and come here.
- I haven't been in trouble with the law. I
- 13 have no open cases. I'm not on probation or parole or
- 14 anything like that. I work. I'm going to school. I'm
- 15 not a bad person. I'm not a violent person. Like I
- 16 said, we've been together 13 years, there's never been
- 17 an issue between us. Never been a charge pressed
- 18 against us, never been a restraining order, never.
- 19 Never had a DYFS case with my children. Nothing.
- MR. DE MARCO: Are you finished?
- MR. A.J. MONTONE: I'm finished. Thank you
- 22 guys very much for listening.
- MR. DE MARCO: Ma'am, do you wish to speak?
- MS. GAIL MONTONE: Oh, absolutely, hon. Gail
- 25 Montone. I'm his mom.

1 I have a couple of questions about the

- 2 Housing. How you -- it has nothing to do with them. I
- 3 want to know why there was a police officer two years
- 4 ago living there with his girlfriend in a two-bedroom
- 5 housing. How do they get that? Because when I moved
- 6 to Garfield over 15 years ago, it was a four-year
- 7 waiting period, supposedly, to get to Garfield Housing.
- 8 But over two years ago, there was a police officer and
- 9 his girlfriend living and they got a two-bedroom
- 10 apartment.
- 11 Currently, there's a police officer living
- 12 I don't understand how. What are the
- 13 requirements for living in the Housing Authority?
- 14 Because I know it's not that it's going to be, oh, we
- need police presence. No, you don't need police 15
- 16 presence on the -- so I'm just asking on my own.
- 17 CHAIRMAN QUILES: I'm sure we have the proper
- 18 documentation for that that we can supply for you.
- 19 MS. GAIL MONTONE: I'm sorry? What's that?
- 20 MS. FIORE: We have proper documentation of
- 21 that. If you want to leave your name and address, and
- 22 I can send that to you.
- 23 MS. GAIL MONTONE: What is that going to tell
- 24 me?
- 25 MS. FIORE: You just asked about why there's

- 1 police officers in the building.
- MS. GAIL MONTONE: Why do they get free
- 3 housing? When there's --
- 4 MS. FIORE: I think you're misinformed. So
- 5 if you would like to leave your name and address, I can
- 6 mail you the documentation that you're looking for.
- 7 MS. GAIL MONTONE: Then I'll have to come
- 8 back here and confront you after I read it all.
- 9 MS. FIORE: That's fine.
- MS. GAIL MONTONE: Okay. Because that
- 11 doesn't seem -- when I first moved here back in 1993,
- 12 it was a four-year waiting period. To get -- it seems
- 13 like it's who you know. If Marty runs the Housing
- 14 Authority place, then it's, hmm, who he knows. And
- 15 that needs to be exposed to the public, to the news,
- 16 whoever. That's where I'm coming from right now.
- I'm just not -- I don't feel this is very
- 18 fair. And what he's had to go through -- I know he's
- 19 old. He's a grown man, but he's still my son. I see
- 20 my grandchildren. They were over this weekend. They
- 21 slept over, the two of them. And it just doesn't seem
- 22 like everything's upfront. And I don't like it. And
- 23 I'm not comfortable with it. Everything needs to be
- 24 exposed. And if there's corruption or if there's
- 25 certain people that get priorities, that needs to be

- 1 exposed as well. Okay?
- I'll leave you my name and number though.
- MS. FIORE: Your address, please.
- 4 MS. GAIL MONTONE: Absolutely.
- 5 MS. BARCKETT: Do you live in the Housing
- 6 also?
- 7 MS. GAIL MONTONE: What's that?
- 8 MS. BARCKETT: Do you live in the Housing
- 9 also? Where do you live?
- MS. GAIL MONTONE: No. I live -- I rent an
- 11 apartment.
- MS. BARCKETT: In Garfield?
- MS. GAIL MONTONE: Right. I sold my house.
- 14 My sister and I sold our house in Fairfield. I lived
- in Garfield for a number of years. Went back to
- 16 Fairfield. We sold my house that my parents had. And
- 17 I'm now living in Kearny. But my granddaughters live
- 18 in Garfield.
- And I just don't like the way it seems
- 20 like -- something's not right. That's it. And, like I
- 21 said, it needs to be exposed or -- I will delve into it
- 22 more. And that's it.
- MS. BARCKETT: Hopefully, when she sends you
- 24 the information about why the officers are there, maybe
- 25 you'll understand it --

- 1 MS. GAIL MONTONE: Yeah. I'd really like to
- 2 know. Because, you know what, they say they have that
- 3 police thing, but there's no reason for a police
- 4 officer and his girlfriend to have a two-bedroom
- 5 apartment. There's no reason for it. Obviously, if
- 6 they're girlfriend and boyfriend, they're sleeping in
- 7 the same bedroom. So why do they need a two-bedroom?
- 8 It doesn't make sense. Common sense.
- 9 Let's get back to basics, everybody, okay?
- 10 That's it. I'll leave you my name and number, address.
- MR. DE MARCO: Any other public comment?
- 12 Is there a motion to close the floor to the
- 13 public?
- MS. BARCKETT: I'll make it.
- MS. GAIL MONTONE: Is this -- is this taped
- 16 or just minutes?
- MS. BARCKETT: No, it's not taped.
- MS. GAIL MONTONE: Just minutes written up?
- 19 Okay.
- MS. FIORE: Motion to close.
- MS. BARCKETT: I did.
- 22 MR. DE MARCO: Ms. Barckett made the motion
- 23 to close. Second?
- MS. RIBAUDO: I'll second.
- MS. GAIL MONTONE: And you meet every month?

- 1 MS. BARCKETT: Yes.
- MS. GAIL MONTONE: So next month. Okay.
- 3 I'll be back.
- 4 MR. DABAL: Yes.
- 5 MS. RIBAUDO: Yes.
- 6 MS. BARCKETT: Yes.
- 7 MR. PUZIO: Yes.
- 8 CHAIRMAN QUILES: Yes.
- 9 MS. FIORE: Adjourned at 6:35 p.m.
- MR. DE MARCO: You have to open it for
- 11 commissioner comment.
- MS. FIORE: I'm sorry. Any commissioner
- 13 comment?
- MS. RIBAUDO: Same old, same old. They did a
- 15 great job with the snow and ice. Very cold in the
